

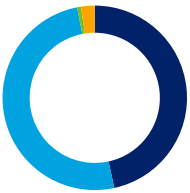

## EOS at Federated Hermes

Over the last quarter we made voting recommendations at **457** meetings (**5,011** resolutions). At **230** meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at **11** meetings and abstaining at **three** meetings. We supported management on all resolutions at the remaining **213** meetings.

### Global

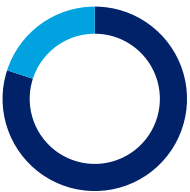
We made voting recommendations at **457** meetings (**5,011** resolutions) over the last quarter.

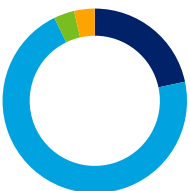
We made voting recommendations at **41** meetings (**365** resolutions) over the last quarter.

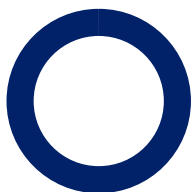

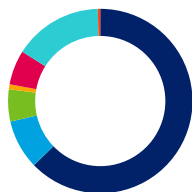

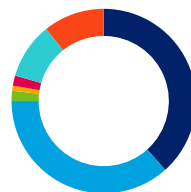

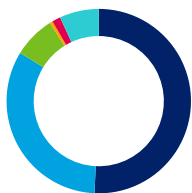

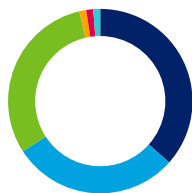
